\* **eLOMA Certified**—Allows Licensed Professionals to submit, electronically, a simplified Letter of Map Amendment (LOMA) request to FEMA. LOMAs are usually issued because a property has been inadvertently mapped as being in a floodplain, but is actually on natural high ground above the base flood elevation. eLOMA submittals can shorten the standard 60-day FEMA review process.
